3. All payments will be made through the FACTS Tuition Management System. You will receive invoicing through FACTS for the registration fee and summer camp tuition after we have processed your application information. Tuition is billed prior to the month of attendance.
 - Registration fee - \$110
 - Weekly Rate - \$260 (*daily rate not available*)

- **STATEMENT OF FAITH:** Myself and my child will uphold the Northwest Christian Schools of Lacey Statement of Faith as stated above.
- **STANDARD OF CONDUCT:** I appreciate and uphold the standards of the school and do not tolerate profanity/obscenity in word or action, dishonor to God and the Word of God, or disrespect to the personnel of the school. I hereby agree to support Northwest Christian Schools Mission Statement,

Statement of Faith and all policies and procedures as found in the handbook. I authorize this school to employ discipline, as it deems wise and expedient, for the training of my child. I understand that the school reserves the right to dismiss any child who fails to comply with the established regulations and discipline or whose financial obligation remains unpaid.

- **TERMINATION:** The school has the right to suspend or terminate the attendance of any child for reasons set forth in the Parent and Student Handbook (or other published documents), for reasons that the school administration considers detrimental to the child, other children of the school or school community, or for the parent's failure to pay all or any part of the parent's financial obligations for child's attendance (including any amounts charged on child's account with the school).
- **FORCE MAJEURE:** The school's duties and obligations under this contract shall be suspended immediately, without notice, during all periods that the school is closed because of force majeure events including, but not limited to, any fire, act of God, hurricane, war, governmental action, act of terrorism, epidemic, pandemic, or any other event beyond the school's control. If such an event occurs, the school's duties and obligations in this contract will be postponed until such time as the school, in its sole discretion, may safely reopen. In the event that the school cannot reopen, due to an event under this clause, the school is under no obligation to refund any portion of the tuition paid.
- **PARTICIPATION IN ACTIVITIES.** I/We consent to the child's summer camp/care attendance, participation in excursions, trips, and activities, off-campus events, field trips, group trips, sporting activities. I/We acknowledge that each of the activities has certain inherent risks, such as a risk of injury or illness due to nature of the activity; transportation to or from the activity; the condition of the premises, environment, or any equipment used in connection with the activity; the actions, inactions, or negligence of the student or others; loss or theft of property; lack of immediate access to medical care; and other risks not reasonably foreseeable at this time; and I/we expressly assume all such risks arising out of the child's participation in the activities. If there is any activity in which I/we feel the child should not participate, I/we will notify the school immediately and at least 24 hours before the activity commences.
- **ADHERENCE TO SAFETY AND HEALTH GUIDELINES:** Guidelines will be set forth for the NCS summer camp/care program and provided to registered families. At that time, agreement to our safety and health guidelines will be required before attending.

Financial Responsibility:

I/We hereby commit to pay all financial obligations on or before due date. I/We understand that:

- Activity fees and Summer Camp fees are **not** refundable.
- All payments will be made via FACTS Management and paid **prior** to the child attending.
- There is a service fee for all NSF returned items.

Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement

In consideration of participating in the Northwest Christian Academy SUMMER CARE, I represent that I understand the nature of this activity and that my child is qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if my child believes event conditions are unsafe, they will immediately discontinue participation in the activity. I fully understand that:

1. Risks and dangers exist in my or my child's participation in SUMMER CARE activities & games;
2. My participation or my child's participation in such activities and/or use of such equipment may result in my injury or my child's injury including but not limited to serious bodily injury, including permanent disability, blindness, eye injury, paralysis and death;
3. These risks and dangers may be caused by my own actions, or interactions, my child's actions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "Releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and
4. By my or my child's participation in these activities I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my participation and my child's participation, in any activity at Northwest Christian Academy.

I, on behalf of myself, my personal representatives and my heirs, hereby release, waive, discharge, hold harmless, and covenant not to sue Northwest Christian Academy, Northwest Christian High School, Foundation Campus, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, and sponsors, advertisers, owners and lessors of premises on which the activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, actions, demands, losses, or damages, on my account, my child's account, caused or alleged to be caused in whole or in part by the negligence of the "Releasees" for any bodily injury, property damage, wrongful death, loss of services or other circumstances which may arise out of my or my child's attendance at SUMMER CARE or my participation in SUMMER CARE.

I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNIFY AGREEMENT. I understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of the agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. AND, I, the minor's parent and/or legal guardian, understand the nature of the above referenced activities and the minor's experience and capabilities and believe the minor to be qualified to participate in such activity. I hereby release, discharge, covenant not to sue and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS each of the Releasees from all liability, claims, demands, losses or damages on the minor's account caused or alleged to have been caused in whole or in part by the negligence of the Releasees or otherwise, and further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the above Releasees. 2022 Health and Safety Agreement

Routines and procedures our NCA summer camp staff will include during Summer Camp:

- health assessment at drop off
- hand washing often and with each transition
- encouraging good hygiene practices – avoiding touching face, covering coughs/sneezes
- cleaning, sanitizing, and disinfecting daily

If you are choosing to enroll your child in Summer Camp at NCA, you are agreeing to the below:

- not bring your child on-site if they are showing signs of COVID-19 or have been in close contact with someone who has confirmed COVID-19
- pick up your child if there are health concerns noted by the summer camp staff
- not hold NCA responsible if you or your child were exposed to COVID-19
- follow the requirements for return to care

If a staff member or child has signs of suspected or confirmed COVID-19, their return date will be determined by the symptoms and circumstances. The NCA office will provide the determined return date by following the Thurston County Health Department COVID Pathway.
