Afterschool sports are available for our 5-8th grade students. Each student is required to have a valid sports physical on file, current Limited Power of Attorney/Health Information Form, and a current Concussion Waiver. Illness/Accident Insurance must carry a Sport Injury Rider for School Athletics (see below).

Late Payment Policy

If payment is more than 14 (calendar) days late, you will be charged a late fee of \$ 500. If payment is more than 21 days late, your students F-1 visa status can be revoked.

Insurance

Proof of Illness/Accident Insurance with coverage while in the U.S. is required for all international students yearly. Your student must provide proof of insurance prior to the first day of school each year. Information on insurance can be found online from several companies. You must have a minimum of \$ 100,000 in coverage. Please read the policy carefully. Not all insurance policies cover sports injuries. If you plan on playing sports while attending NCA you will need sports injury coverage. Do **not** send money for the insurance policy to NCA.

Host Family Room and Board - (if applicable)

- \$ 12,000 per year payable in 10 equal installments of \$ 1,200 per month. Host fees include transportation to and from school, food and hygiene supplies as provided for family, and utilities. Stipend does not include long distance phone calls, cell phone or private phone line. Cell phone plans may be purchased separately.
- **Please pay your host family directly by the 1st of the month.** Do **not** send this money to NCA.

Spending Money

Please provide your student with a reasonable allowance for extras while they are here so they may participate in school events and activities.

Statement on the Sanctity of Human Life

The Bible itself, as the inspired and infallible Word of God that speaks with final authority concerning truth, morality, and the proper conduct of mankind, is the sole and final source of all that we believe. For purposes faith, doctrine, practice, policy and discipline at Northwest Christian Schools, our School Board is the final interpretive authority on the Bible's meaning and application.

Northwest Christian Schools of Lacey's goal is to inspire each student to pursue excellence in moral character, academics, and servant leadership. The development of moral character in academics is among our chief objectives for students as they prepare for high school and life beyond high school.

- **PARENT/STUDENT HANDBOOK:** The policies and responsibilities as stated in the Parent/Student Handbook will be upheld and supported. NCS administration reserves the right to make changes. These, along with promotional materials and statements, may be changed without formal notice.
- **ACADEMIC PLACEMENT:** Grade placement is based on successful completion of the academic year while being in good standing both academically and behaviorally. Placement is in accordance with the school's standard of admissions or retention practices. Curriculum changes/decisions are made at the school's discretion.
- **STANDARD OF CONDUCT:** I appreciate and uphold the standards of the school and do not tolerate profanity/obscenity in word or action, dishonor to God and the Word of God, or disrespect to the personnel of the school. I hereby agree to support Northwest Christian Schools Mission Statement, Statement of Faith and all policies and procedures as found in the handbook. I authorize this school to employ discipline, as it deems wise and expedient, for the training of my child. I understand that the school reserves the right to dismiss any child who fails to comply with the established regulations and discipline or whose financial obligation remains unpaid.
- **TERMINATION:** The school has the right to suspend or terminate the attendance of any student for reasons set forth in the Parent and Student Handbook (or other published documents), for reasons that the school administration considers detrimental to the student, other students of the school or

school community, or for the parent's failure to pay all or any part of the parent's financial obligations for student's attendance (including any amounts charged on student's account with the school).

- **FORCE MAJEURE:** The school's duties and obligations under this contract shall be suspended immediately, without notice, during all periods that the school is closed because of force majeure events including, but not limited to, any fire, act of God, hurricane, war, governmental action, act of terrorism, epidemic, pandemic, or any other event beyond the school's control. If such an event occurs, the school's duties and obligations in this contract will be postponed until such time as the school, in its sole discretion, may safely reopen. In the event that the school cannot reopen, due to an event under this clause, the school is under no obligation to refund any portion of the tuition paid.
- **PARENT'S COMMITMENT TO TRUTHFULNESS IN THE ADMISSIONS AND ENROLLMENT PROCESS:** The school is relying on the completeness and truthfulness of the information provided by the parent in the admissions and enrollment process. If the school determines, after the student has been admitted and enrolled, that the parent was not truthful in the admissions and enrollment process on any issue that the school, in its sole discretion, finds to be important, the school has the absolute right to terminate this contract. There will be no refund of tuition where such termination occurs and any unpaid balance is payable in full according to the terms of this contract.
- **PARENT'S COMMITMENT TO COOPERATION:** Parents and family members agree to a positive constructive relationship with each other and the school when dealing with school matters, on and off campus and in school and at school events. It is the responsibility of the parents to inform and provide copies to the school of any court orders and updated custodial or parenting plans.
- **REIMBURSEMENT FOR DOMESTIC LEGAL ISSUES:** Parents understand and agree that the school's primary purpose is to provide educational opportunities to the students within its institution. Parents also understand that it is disruptive to the school for a parent to involve the school (or any of its employees) in domestic legal disputes between the parents and that the school often must pay for legal fees and costs associated with such issues. Therefore, the parent agrees to promptly reimburse the school for all expenditures incurred by the school as a result of the parent's domestic legal disputes, including, but not limited to: Parental disagreements about student's education or placement; divorce proceedings; custody proceedings; and/or modifications of custody proceedings. Cost incurred may involve reasonable attorneys' fees/costs to prepare for and/or attend depositions, trials, or hearings; communication with parent or parent's counsel, guardians ad litem or attorneys ad litem; respond to subpoenas; drafting letters or motions; and performing research. Costs include the cost of copying documents, providing records, engaging substitute teachers or temporary employees, computerized research, and travel expenses. Parent agrees to reimburse the school for such fees/costs within thirty (30) days of school billing parent for such expenses. Any dispute between the parents regarding which parent may owe which portion of the bill should be resolved between the parents so that the bills for reimbursement to the school can be paid on a timely basis. Parent's failure to pay such fees/costs promptly will result in dismissal of the family from the school.
- **PARTICIPATION IN ACTIVITIES.** I/We consent to the student's school attendance, participation in excursions, trips, and activities (including but not limited to athletic programs, club programs, performing arts programs, off-campus events, field trips, group trips, camps, sporting events and other school-related travel or activities) during regular school hours and beyond the end of the school day, on and off campus (collectively referred to as "activities" and each individually as "activity"). I/We acknowledge that each of the activities has certain inherent risks, such as a risk of injury or illness due to nature of the activity; transportation to or from the activity; the condition of the premises, environment, or any equipment used in connection with the activity; the actions, inactions, or negligence of the student or others; loss or theft of property; lack of immediate access to medical care; and other risks not reasonably foreseeable at this time; and I/we expressly assume all such risks arising out of the student's participation in the activities. If there is any activity in which I/we feel the student

should not participate, I/we will notify the school immediately and at least 24 hours before the activity commences.

- **EDUCATIONAL OUTCOMES:** The school does not guarantee any specific type of educational program, class size, class placement, enrollment cap, employees, teaching style, curriculum, benefit, or outcomes.
- **ADHERENCE TO SAFETY AND HEALTH GUIDELINES:** Guidelines will be set forth for the upcoming school year before school begins next fall. At that time, agreement to our safety and health guidelines will be required before attending school.

FINANCIAL RESPONSIBILITY:

NCS TECHNOLOGY POLICY

Every student (and parent who desires their child to have access to school technology) must comply with the following rules of access:

- Nothing done on a school computer shall be considered private. School officials are authorized to access any student's material at any time;
- Students will only access the internet from a computer when a teacher is available to monitor the students' activities;
- The school has the right and ability to recall all sites accessed by the students;
- The school shall maintain site-blocking software to block and filter out inappropriate sites;
- No student shall:
 - Attempt to bypass any site-blocking hardware or software, including, but not limited to VPN servers or extensions
 - Access anything contrary to the Statement of Faith, Mission, Vision, and/or Core Values of Northwest Christian Schools, (including but not limited to anything: sexually inappropriate or suggestive in nature, blatantly offensive, ungodly material, lewd or obscene language)
 - Send and/or receive messages to/from other internet sites without teacher supervision and/or authorization
 - Use another person's password
 - Trespass into another person's folders or files, or digital profile
 - Violate copyright laws
 - Buy or sell anything via the internet
 - Change any of the computers' set-ups or settings

PERSONAL TECHNOLOGY POLICY (Personal Cell Phones & Other Devices)

Students will face disciplinary action for texting, posting, sending, receiving, forwarding, or participating in any of the following areas ON OR OFF CAMPUS via a cell phone, computer, or any other electronic device. These areas are:

- Information containing blasphemy: Irreverence for God, Jesus Christ, and those things held to be holy by the Word of God, direct contradiction of Northwest Christian Schools of Lacey Statement of Faith, Mission, Vision, and/or Core Values.
- Inappropriate language: Obscenities, profanities, vulgarities, or lewd comments
- Harassing statements: Personal attacks such as discriminatory, inflammatory, threatening, or disrespectful language. Knowingly false or defamatory statements.
- Sexually explicit or suggestive messages, photos, or images (sexting)
- Sending, receiving, sharing, possessing, or intentionally viewing pictures, text messages, or e-mails that contain a sexual message or image. Violation of this policy may result in expulsion. Appropriate local, state, and federal laws will be followed and law enforcement will be contacted if warranted.
- Students must ask permission prior to recording video or audio of any conversations, instructions, or interactions on school campus between students or school employees. It is a criminal offense in WA to record without consent – RCW 9.73.030.

Violation may result in expulsion. Appropriate local, state, and federal laws will be followed and law enforcement will be contacted if warranted.

Note: Students must promptly report any such known activities to a teacher or a school administrator.

PERSONAL ELECTRONIC ITEMS

Electronic items such as games, iPods, cameras etc. are not allowed at school. If your child needs to bring such an item for the purpose of using it after leaving campus, they may check the item in to the office for safekeeping until leaving at the end of the day. NCA is not responsible for such items being lost, damaged or stolen if the child does not follow this policy.

Violating these rules will result in the forfeiture of the electronic item to the office until a parent is able to pick it up.

PERSONAL CELLULAR DEVICE USAGE POLICY

We encourage students to not bring cell phones and other such devices (smart watches capable of texting, calling, etc.) to campus. Our landlines at school are available for students to call parents if needed as well as for parents to call and leave messages for their child or to speak with their child if desired. If a student does bring a cell phone to campus, the following rules apply:

All students who bring a cellular device onto campus must hand it to the homeroom teacher upon entering the classroom. The teacher will keep the device in a safe place until the end of the school day at 3:00pm at which time the student will receive the device back from the teacher. During before and after school care these devices are **only allowed to be used with permission from a school staff member** (administrator, faculty, office staff, extended care, or coach) and are otherwise to be kept with the teacher, off and not used. On field trips, at the teacher's discretion, these devices will either be collected by the teacher at the beginning of the field trip, or students will be allowed to keep their devices in their pocket.

Violations could include but are not limited to:

- The parent being called to pick up the device from the school office
- The student not being allowed to have a cellular device on campus
- For continued violations, the student could receive a detention or suspension

Students and Parent/Guardians Acknowledge That:

- The school's internet filter is in compliance with the Children's Internet Protection Act (CIPA). The filter applies to any device that is connected to the school's wireless connection, whether it is a school-issued chrome book or a personal laptop. However, the school has no way of filtering student's personal cell phone or devices that have internet or personal "hot spots" that are separate from the school's Wi-Fi.

During the course of the school year, additional rules regarding the use of personal devices may be added or modified.

ELECTRONIC MEDIA

NCS continues to explore the ways in which online communication and collaboration through electronic media can empower teachers, students, parents, and staff. NCS understands the importance of these interactions to provide updated communication and share campus highlights.

Electronic media includes all forms of social media, such as text messaging, instant messaging, electronic mail (e-mail), web logs (blogs), electronic forums (chat rooms), video-sharing websites (e.g. YouTube), editorial comments posted on the Internet, and social network sites (e.g., Facebook, X, LinkedIn, Instagram). Electronic media also includes all forms of telecommunication such as landlines, cell phones, and web-based applications.

At Northwest Christian Schools of Lacey (NCS), teachers, students, staff, and other school community members use electronic media as a way to connect with others, share resources, create educational content, enhance the classroom experience, and network within and outside of the school community.

Below are guidelines for members of the school community (students, parents, faculty, administrators, and staff) who represent NCS in social media spaces and interact with one another.

- Use good judgment - Regardless of your privacy settings, assume that all of the information you have shared on your social network is public information; in addition, avoid engaging in postings of an inappropriate nature (related to controversial issues or cyberbullying).
- Be respectful - Always treat others in a respectful, positive, and considerate manner and do not disparage the school or school community members through social media.
- Be confidential - Do not publish, post, or release information that is considered confidential or private. Online “conversations” are never private. Do not use social media to address any concerns or frustrations.
- Respect private and personal information - Never share or transmit personal information of students, parents, faculty, staff, or colleagues online.
- Post images with care - Respect brand, trademark, copyright information and/or images of the school and do not post photos of students who are on the “Do Not Photo” list.

NCS COPPA STATEMENT - Parents of school-age children under the age of 13,

In order for Northwest Christian Schools of Lacey to continue to be able to provide your student with the most effective web-based tools and applications for learning, we need to abide by federal regulations that required parental permission as outlined below.

Our school utilizes several computer software applications and web-based services, operated not by this school, but by third parties. These may include Quizlet, Renaissance Accelerated Reading, Google classroom and similar educational programs.

In order for our students to use these programs and services, certain personal identifying information, generally the student’s name and email address, must be provided to the website operator. Under federal law entitled the Children’s Online Privacy Protection Act (COPPA), these websites must provide parental notification and obtain parental consent before collecting personal information from children under the age of 13. For more information on COPPA, please visit [Federal Trade Commission Complying with COPPA: Frequently Asked Questions](#).

The law permits schools such as ours to consent to the collection of personal information on behalf of all of its students, thereby eliminating the need for individual parental consent given directly to the web site operator.
