## Immunization Requirements

In accordance with Washington State Law ALL public/private schools in the State of Washington must have an official Washington State Certificate of Immunization form on file with the school for each child in attendance. All CIS forms must be legible and contain the month, day and year of vaccination and a parent/guardian signature OR a medical, personal or religious exemption form on file (see below).

DTap (Diphtheria, Tetanus, Pertussis)	4 doses required	5 doses 4 doses are acceptable only IF dose 4 is given on or after the 4th birthday AND at least 6 months after dose 3.	
Tdap (Tetanus, Diphtheria, and Pertussis)		7 <sup>th</sup> – 12 <sup>th</sup> grade 1 dose required	7 <sup>th</sup> – 12 <sup>th</sup> grade Tdap at age >10 years
IPV or OPV (Polio)	3 doses required	4 doses required Vaccine Doses may be fewer than listed depending on your child's situation	The final dose must be given on or after the 4 <sup>th</sup> birthday AND a minimum interval of 6 months from previous dose
MMR (Measles, Mumps, Rubella)	1 doses required	2 doses required	MMRV (MMR + Varicella) may be used in place of separate MMR and varicella vaccines.
VAR Varicella (Chickenpox)	1 doses required OR Health care provider verified disease history	2 doses required OR Health care provider verified disease history	

# **Immunization Status Forms and Exemptions**

New immunization laws were implemented August 2020. All immunization records for incoming new students or updates for current students turned into schools or child care centers are required by state law to be medically verified.

Here are some examples of medically verified immunization records:

- Request a complete immunization record from your health care provider, clinic, or local pharmacy
- Request a complete immunization record from the Department of Health

## **Certificate of Exemption**

Washington State Law allows parents or guardians to exempt their child from the school or childcare immunization requirements. Exemptions may be claimed for personal/philosophical, religious or medical reasons. Measles, mumps, and rubella may not be exempted for personal/philosophical reasons. To request an exemption a completed Certificate of Exemption must be submitted to the school or child care center.
